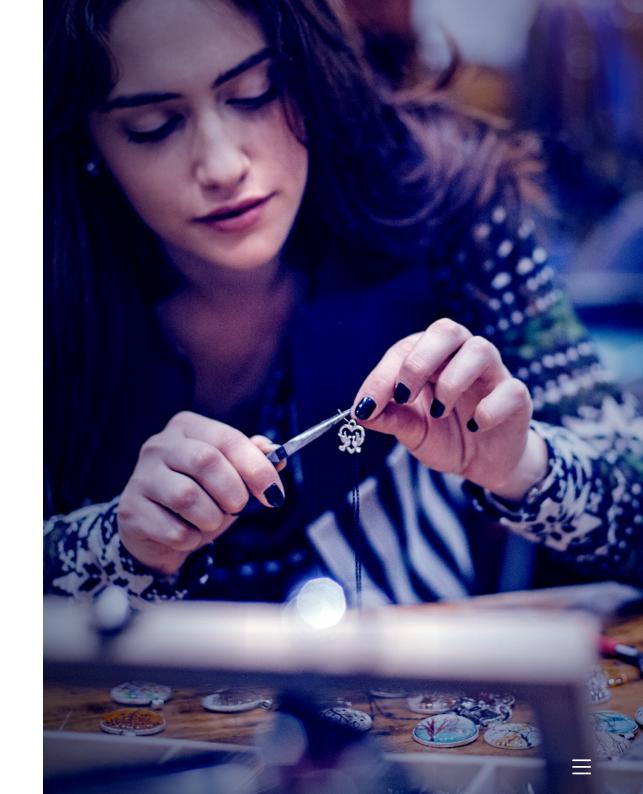

Specialist/Custom:

Process and characteristics of a Liberty Approved Fund List.

Approach

- Ensuring that all SA and international asset classes are covered.
- Bias towards multi-asset solutions (believe that managers can add Tactical Asset Allocation alpha).
- Best of group and external solutions.

Considerations

- Manager ratings: Silver and Gold.
- Bronze rated managers only by exception.
- Operationally viable managers.
- AUM in the funds.

Manager Research Process

- Propose Approved List and supporting analysis to Product Oversight Approval Committee.
- The Approved List has two categories:
 - Funds linked to defined client outcomes.
 - Funds not linked to defined client outcomes (mostly specialist funds like property and feeder funds)

Product Oversight and Approval Committee (POAC)

- Approved List review and sign-off.
- Quarterly monitoring of the Approved List.
- Agree and govern exceptions to the process.
- Consider fund ideas for inclusion.

Gold: Good alignment of philosophy, process and portfolio construction with comprehensive risk management. Solid and stable team. We are confident that this fund or capability has a high likelihood of delivering at least half of our alpha expectations versus a suitable benchmark, and has the potential to significantly exceed our expectations. This fund is highly competitive and is expected to consistently rank in the top third or top quartile of peers when measured over an appropriate length of time.



Silver: Reasonable alignment of philosophy, process and portfolio construction with adequate risk management. The manager's ability to generate alpha versus a suitable benchmark is not convincing. Performance is expected to be around the average of the peer group and anticipated to rank in the middle third of its relevant peer group.



Bronze: Some alignment of philosophy, process and portfolio construction. Weaker risk management. There are angles to the manager's approach, which are likely to lead to underperformance versus peers and/or benchmarks over time. We anticipate that this fund or capability will consistently rank in the lower third of its peer group category over time.

The list will therefore be reviewed on an annual basis to ensure that the selection available is relevant, comprehensive and meets client needs. There is continuous oversight of the portfolios and managers on the list, which enables us to make changes to the list on a more dynamic basis, if required.

We also recognise that gaps may emerge as preferences change. Financial Advisers will therefore have an opportunity to make requests for changes to the list, and requested managers and portfolios will be subject to the same thorough due diligence process that all approved funds go through.
